We would like to invite you to participate in our Yard Sale/ Vendor Day at the Van Nest Hoff Vannatta Farmstead. Please read, sign and return the attached Registration form with your payment. Form and payment must be received no later May 20, 2019.

The event fee is \$20 for a 20 x 20 space, you must provide your own tables, chairs and canopies if wanted. Because spaces are limited, preregistration is required. The registration fee must be paid in full prior to your spot being reserved. Set up begins at 7:00 a.m. This is a rain or shine event and is held on the same date as the Harmony Township town wide yard sales.

The Farmstead is a historic property along 519 in Harmony Township, NJ. The Farmstead was added to the National Register of Historic Places on December 28, 2005 for its significance in agriculture and architecture.

All items for sale must be displayed within the allotted space rented. All trash, litter or debris brought to the farmstead must be taken away by the vendor. No vendor may display or sell food or beverages for consumption.

Please note the following items are prohibited to be sold at this event. If anyone is to sell the following items listed you will be asked to leave the event and your fee will not be refunded:

*The sale of firearms, ammunition, explosive materials, chemicals, pornographic or offensive materials, livestock, drugs or drug paraphernalia, alcoholic beverages, fireworks, illegal or unlawful materials or services, or any service that may be deemed offensive. The Harmony Township Historical Society reserves the right to have any item or items removed from sale at its sole discretion.*
